Information for the competition

- Submission of documents: documents are submitted no later than 90 minutes before the first player: player's club cards, a photo of the club's playing equipment, a signed conditions of participation form (which also confirms the validity of the medical examination) and an advertising contract. The documents hold down the Chief referee until the end of the competition.
- Getting the forms: after submitting the documents, the team entry form and player sheets for qualification rounds will be provided. For the semifinals, matches for 3rd place and the finals - Thursday after the end of qualifying.
- Player sheets (Info): Please fill in all relevant information: name and surname of the player, NBC ID number, country, name, and surname of the coach and his NBC ID number. Also, the lane on which the player plays (and for the substitute when he comes to play). After game finishing, the player's signature.
- Substitution info: According to point 8.5.1 under c) ISO) - Before the start of the match each team receives two cards for substitution (E1 + E2). By handing over the substitution card to the referee, the substitution is announced and is carried out immediately - this applies to the semi-finals, matches for 3rd place and the final. In the qualifications, the substitution is done without substitution card but is also carried out immediately.
- Team entry form submission: For qualifications – 75 minutes before the schedule of first player.
- Submission of the list for playing: For qualifications - according to point 8.3.2.2.1 under e) ISO - Player must register to the referees no later than 30 minutes before the official start, in playing equipment and with his individual player sheet. If he fails to do so he loses the right to play. A player who competes in the qualifications for team competition is also considered an individual player.

For semi-finals, 3rd place matches and finals - according to point 8.3.2.2.1 under a) ISO - The submission of players list for both teams for the match must be done 45 minutes before the start of the match. Positions 1-6 on the application are also the order of playing of both teams.

In team competitions, the entire team must introduce itself to the referees in playing equipment no later than 30 minutes before the official start of the match. If any player is not present, he loses the right to play.
- Playing equipment: The playing equipment of individual players is subject to the provisions of the regulations for club teams (point 7.5 ISO). - Club teams must have the club emblem and / or club name on the jersey.

Wearing the same color shorts and / or cycling pants, as well as shorts or skirts is considered a unique player outfit. Visible underwear and / or protruding underwear, as well as functional underwear, must be the same color as the playwear outerwear.
- Notes for Coach: For offenses, indiscipline and violation of fair-play, a warning by the SpO. They take their place from the start of warm-up.

- Presentation of players on the lanes: Semifinals, matches for 3rd place and finals - the whole team 10 minutes before the start of the match - the teams for the match are on the lanes, the referee announces the match and makes a presentation, sports salute.
- Players entry and announcement of results: entry accompanied by a referee, each player goes to his starting lane, at the referee's signal the time starts, the warm-up begins. During the warm-up, individual players will be introduced. After the end of the match, the players on the referee's command go to the top of players space and the results are announced.
- Starting the match, stopping and changing lanes: always at the referee's signal, time starts at the referee's signal.
- Cleaning playing space: The coach cleans the playing space
- Warm-up: 5 min
- Photographing and recording: it is possible to take pictures and record players from the lane area during the warm-up. The last two minutes of warm-up this is no longer allowed.
- Interruption of the lanes: Time stops for lanes: left and right only 2 adjacent lanes, the remaining lanes plays on

Additional information for clubs

- All teams with the player's club cards must submit to the referee a completed and signed disclaimer for all participants in the competition (delegation and players). You can find the form on the website <https://www.wnba-nbc.com/forms> (Form - Conditions of participation), on the same page you can also find the text "Terms of participation" which you sign in the form.
- Clubs that have advertisements on the jersey send a request for approval of the advertisement to the WNBA. The WNBA will send you an invoice and approval for advertising.
- Players or members of the delegation who do not have a signed Anti-Doping Statement can not participate in the competition. The published list of players includes a list of those who did not submit signed statements.

The host and / or Chief Referee may give some additional instructions for the competition before the start of the competition and will provide them to you together with the accreditation.
