Along with the registration form B, it is mandatory to submit photos of the players and the delegation (if they exist in the NBC database, then it is not necessary).

# 12. Entry fee

Participating nations must comply with the Rules of Financial and Coasts of Journey of the NBC the journey -, alimentation -, accommodation- and subsistence expenses of their members of delegation as well as the entry fee and if necessary the fine. The associations will be sent an invoice over the entry fee.

XI. World Championship Ninepin Bowling Classic 2025 National Teams each match of a team 200,00 EURO

Entry fee for the group matches the association will receive an invoice and must pay until to the **April 30, 2025** through transfer at the account of the NBC. The entry fee for the knockout matches (quarter-, semi- and final) must be paid according to the received invoice after the championship.

# 13. Right to participation

XI. World Championship Ninepin Bowling Classic 2025 National Teams Women and Men The members of NBC have the right to take part with one Team Women and one Team Men at the competitions.

Further preconditions are for the participation, that

- the responsible national association has declared the participation with registration form A and has named the members of delegation with registration form B.
- the national association has no arrearages on payable dues, charges, or other payments to the WNBA and / or to the NBC and has transferred the entry fee until to the April 30, 2025, on the account of the NBC.

# 14. Accommodation

The organizer in the city does not make reservations of overnight stay in the hotels for the nations. The booking of bedrooms is exclusive matter of the member associations.



# 15. Permission of start, physical examination, and doping

The permission to start have all sportsmen:

- a) XI. World Championship Ninepin Bowling Classic 2025 National Teams Women and Men see point 10 of the invitation
- b) they are reported on the registration form B up to 15 players women and 15 players men. After the May 21, 2025 no further players that are not mentioned on the registration form B can be registered with NBC for the XI. World Championship men and women, team. For each player and member of the delegation, it is necessary to submit a photo in order to have the right to participate.
- c) they are physical fit for the requirements of the competition. About of the medical investigation will referenced to the figure 7.4 ISR. The organizer takes over no liability for the infractions or other health damages.
- d) they legitimize towards the chief of referees through a player pass.
- e) The Office of NBC notifies the chief of referees the permission to start from the nations named players and also the assistant of the player, there is entitled. The chief of referees will check at place the proof of identity of the sportsmen and also the assistants and the attests of the medical investigations.

## Doping

Doping is according to the guidelines of the IOC, the Wada and the Anti-DOPING-RULES of the World Bowling (WB-Code) strict prohibits. If there will be any offence against the anti-doping-rules ascertained in the frame of a control by competitions, the obtained results will be cancelled and if necessary the medals will be denied. Further preventive measure – as admonishment, dissuasiveness, closing on term or lifelong closing – are after the numeric 10.2 and 10.3 WB-Code. Decisive for the not allowed medicaments (things that are considered doping) is the list of DOPING of the Wada – Prohibited List (www.wada-ama.org), valid at time of the competition. Get pointed completing on the figure 2.5 SpO "Alkoholverbot".

The Office of NBC is to transfer with the registration form B also the signed declarations of the sportsmen as also the signed declarations of the head of the delegation, trainer and further employee of the delegations after the Annex 2 of the WNBACode (look Annex at this invitation to competitions). Only a submittal of these declarations will make possible the right to start of the sportsmen from a nation by both events. Not exists an explanation of one sportsman, so is only from this precluded from starting.

Should itself yield while of the competition suspicious facts, that sportsmen have taken in medicaments or alcohol, the basically or by reason of the quantity for sportsmen are prohibited, the arbitration board is legitimated, to order on a medical control. The involved sportsman is committed, to render this order consequence.

That is valid also for in advance not presaged, after closing of a competition queuing dope test. In the event of the refusal of sportsmen are the giving's in advance to transpose in the WBCode.

By noncompliance of the prevention conditions exists no permission to start in the event.

## 16. Sportswear, Assistant

The country coat of arms or the association coat of arms must be visible on the playing dress.

The advertising can be carried on the playing dress up to a size of 400 cm<sup>2</sup> for each advertise and additional at training overall likewise up to a size of 400 cm<sup>2</sup> for each advertise. Advertising for alcohol (excluded beer) and tobacco isn't permitted.

# Advertising permits shall be submitted.

The assistances of a player while one match takes place, can take only if the assistant

- a) is authorized through the NBC (message on registration form B)
- b) wears likewise sportswear and sport shoes.



# 17. Realisation

The drawing of groups will be together with the Champions League quarter-final draw (between 10 and 17 December 2024). The exact location and time will be announced on the NBC website (the draw will also be streamed online)

# **18.** Titles and Honours

For this look at Implementing Regulation figures 13 and 14 World Championship. The honours of winners will get according to the giving's in advance in the schedule executed on Olympic kind.

# 19. National flag

Each nation is to bring along obliged their national flag and while at the event will keep it ready in case of need. The national flag is only to be given to the organizers, if they come to you and say, they will have the flag. Largeness of the flag: For affixing in the hall: 2 meters

# 20. Protests

A protest must be written brought in from head of the delegation or whose representative or the sportsman immediately after the reason becomes known, and the protest fee of 100.00 EURO must be paid at the same time. If the arbitration board accepts the protest, the team submitting the protest will be refunded protest fee; if the protest is rejected, the protest fee will be forfeited to the benefit of the NBC.

For all other matters, reference is made to the NBC's legal and procedural rules.

# 21. Press

All Reporters have to be accredit by the organizer. Reporter that arrive with a nation are no members of the respective delegation.

The reporters have to identify themselves each time through from organizer by the accreditation leaves press card.
